**2. HOLD HARMLESS**

The Dealer shall protect, defend, indemnify and hold JK and its respective assigns and its attorneys, accountants, employees, officers and directors harmless from and against all losses, costs, liabilities, claims, damages and expenses of every kind and character, as incurred, resulting from or relating to or arising out of Dealer's use of JK equipment and JK's use, storage, and modification of any data recorded by Dealer in providing services to the Dealer.

**3. ENTIRE AGREEMENT**

The Agreement and any other agreements and/or documents referenced herein, contain the entire agreement between JK and the Dealer and supersede all previous agreements. In the event there are any inconsistencies between this Agreement and any other agreements, this Agreement shall govern.
